After Adoption



- 11 years experience family finding for children with complex needs.
- 21 years experience developing adoption support services to all parties in adoption across England and Wales.

Our Concerns



- 1 in 5 adoptive placements fail without appropriate support.
- Trend analysis of referrals in 2003/04 showed increase in need for support from adoptive families.
- 60% of LAC have suffered abuse and neglect.
- Diminished life chances of children remaining in LAC or returning to care after disruption.

Targetted response to need



- Development of SafeBase parenting programme in 2004
- Pilot programme support by DFES funding 'Strengthen Families'
- Independent evaluation indicated increased parent sensitivity to parenting.
- Immediate reduction in referral rates for ongoing support.

SafeBase



- Assessment
- 4 day Training Programme
- Ongoing Support Groups
- Raises parental awareness to the impact of early trauma, attachment issues and related behaviours

Delivery impact to date



- 316 children referred
- Majority referred between 2–5 years after placement
- On referral 40% were at the point of disruption
- 32% had previous CAHMS involvement

Proven results



- 310 children's placements sustained
- Parents changed responses to children
- Greater family harmony and closer relationships



Challenge: How to increase public benefit



Response:

- Licensing intellectual property to other agencies
- development in Scotland with support of Scottish Government
- discussions with other VAA's/LA's partnerships/commissioning
- discussions in other nations Northern Ireland

Innovation



- Development of 3 sector partnerships between private, third sector and public sector.
- Shared vision to make SafeBase available to all adoptive parents by 2016.
- £1m private sector funding to support plan





Innovation to action



- Strategic development of LA partnerships with 50% matched funding to public purse for 3 years.
- Matched funding for individual adopters unable to access support they need – removal of postcode letters.
- Licensing agreements with other VAA's increase public benefit. Pay resources.
- After Adoption provides SafeBase to all families placed via the agency – funded by post adoption element of interagency fee

Matched Funding - Outcomes



LA's must agree to strategic improvements

- Increased number of adopters
- Increase stability for children
- Improve family relationships
- Raise average age of adopted children
- Increase sibling placements
- Reduce need for continuous expensive interventions

Monitoring & Evaluation



- Follow up evaluation of initial SafeBase graduates on longevity and quality of placement.
- LA's to participate in monitoring of impact on disruption rates, remit and reduction in LAC population.

Social Impact



- SafeBase costs 10% less than keeping a child in care for 1 year.
- A year on year saving of up to £50k for a child in care.
- Longevity of placement reduces NEET figures for children.
- £1.5m saving to public purse for every 20 children placed and sustained in placement.

Agreements for long term benefit



- LA disruption rates 20%
- VAA standard disruption rates 6%
- SafeBase success rate under 2%

Sustainability



- Deliverable outcomes leads to sustainable funding
- Evidence based performance
 - longevity of placement
 - decreased dependence on services
 - vulnerable children having happy experiences of adoption.
- Social impact quantifiable figures
- Attract interest from future social investors.
